






About Us

- Administrative headquarters in Atlanta






Who We Are

Aging in Place helps older adults age at home and in communities of their choice by collaborating with human service organizations to evaluate individual needs.




What We Do

NEIGHBORHOOD REVITALIZATION

Neighborhood Revitalization responds to neighborhood aspirations in local communities by collaborating with residents and partners to improve quality of life.

RESTORE

ReStore is a home improvement store and donation center that sells new and gently used furniture, appliances, home goods, building materials, and more.



ADVOCACY

- Need for housing.
- Ability to pay.
 Willingness to partner.
 Live or work in Illinois.
- Meet income guidelines.




The need for affordable housing

- 43.6% of renters in DuPage County pay more than 30% of their income on housing
- 25.5% of mortgage owners in DuPage County are spending more than 30% of their income on housing
 - Spending a high percentage of household income on housing can create financial hardship, especially for lower-income families. With a limited income, paying a high rent may not leave enough money for other expenses, such as food, transportation and medical. Moreover, high rent reduces the proportion of income a household can allocate to savings each month.

Habitat Impacts Outcomes

- Strong and stable households are foundational to child development and growth.
- When a home fosters (instead of hinders) health and safety, families can flourish.
- Owning an affordable home allows homeowners to lift their entire family by saving for their futures and investing in educational opportunities - bolstering job opportunities and long-term career growth.
